FINANCIAL 15 SPLIT CORP. II

Regular Monthly Dividend Declaration

Toronto, Ontario – April 18, 2007: Financial 15 Split Corp. II (“Financial 15 II”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable May 10, 2007 to shareholders on record as at April 30, 2007.

Since inception Class A shareholders have received a total of \$3.25 per share (including one special distribution of \$0.25 per share) and Preferred shareholders have received a total of \$1.33 per share inclusive of this distribution, for a combined total of \$4.58.

Financial 15 II invests in a high quality portfolio consisting of 15 financial services companies made up of Canadian and U.S. issuers as follows: Bank of Montreal, The Bank of Nova Scotia, CIBC, Royal Bank, Toronto-Dominion Bank, National Bank of Canada, ManuLife Financial, Sun Life Financial, Great-West Lifeco, CI Financial Inc., Bank of America, Citigroup, JP Morgan & Chase, Merrill Lynch, Wells Fargo. Shares held within the Portfolio are expected to range between 4-8% in weight but may vary from time to time.
