Regular Monthly Dividend Declaration

Toronto, Ontario – July 18, 2008 / Marketwire: Financial 15 Split Corp. (“Financial 15”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable August 8, 2008 to shareholders on record as of July 31, 2008.

Since inception Class A shareholders have received a total of \$6.10 per share (including two special distributions totaling \$0.50 per share) and Preferred shareholders have received a total of \$2.47 per share inclusive of this distribution, for a combined total of \$8.57.
