### Regular Monthly Dividend Declaration

(“Financial 15”) declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable June 10, 2008 to shareholders on record as of May 30, 2008.

Since inception Class A shareholders have received a total of \$5.90 per share (including two special distributions totaling \$0.50 per share) and Preferred shareholders have received a total of \$2.39 per share inclusive of this distribution, for a combined total of \$8.29.

Shares held within the portfolio are expected to range between 4-8% in weight but may vary at any time.
