### Regular Monthly Dividend Declaration for Preferred Share

Since inception Class A shareholders have received a total of \$3.70 per share and Preferred shareholders have received a total of \$1.86 per share inclusive of this distribution, for a combined total of \$5.56.

Morgan Chase, Lehman Brothers, Merrill Lynch, Morgan Stanley, SunTrust Banks, U.S. Bancorp, Wachovia Corporation, Washington Mutual and Wells Fargo. Shares held within the Portfolio are expected to range between 4-8% in weight but may vary from time to time.
