### Regular Monthly Dividend Declaration

**Toronto, Ontario – July 19, 2006:** US Financial 15 Split Corp. ("US Financial 15") declares its regular monthly distribution of \$0.10 for each Class A share (\$1.20 annually) and \$0.04375 for each Preferred share (\$0.525 annually). Distributions are payable August 10, 2006 to shareholders on record as at July 31, 2006.

Since inception Class A shareholders have received a total of \$1.70 per share and Preferred shareholders have received a total of \$0.76 per share inclusive of this distribution, for a combined total of \$2.46.

US Financial 15 invests in a high quality portfolio consisting of 15 U.S. financial services companies as follows: American Express, American International Group, Bank of America, Citigroup, Fifth Third Bancorp, The Goldman Sachs Group, J.P. Morgan Chase, Lehman Brothers, Merrill Lynch, Morgan Stanley, SunTrust Banks, U.S. Bancorp, Wachovia Corporation, Washington Mutual and Wells Fargo. Shares held within the Portfolio are expected to range between 4-8% in weight but may vary from time to time.
